

## Terms & Conditions for the “Guess your 10k time”

### 1. Introduction

- a) The Prize Draw is organised and run by Deckers UK LTD (“Deckers”), who can be contacted at 130 Shaftsbury Avenue, London W1D 5EU
- b) By entering this Prize Draw you agree to these Terms and Conditions (the “Terms”) and any decisions reached by Deckers, which are final and binding in all matters related to this Prize Draw.
- c) The Prize Draw starts at 09:00 GMT on the 26th of January 2023 and ends at 00:00 GMT on the 4<sup>th</sup> of February(the “Prize Draw Period”).

### 2. Who can enter this Prize Draw?

- a) Participant must:
  - i. be a resident of, with a postal address in: Austria, The Netherlands, Belgium, Germany, UK & Ireland, France, Spain, Poland, Finland, Denmark, Norway
  - ii. be aged 18 or over.
- b) The Prize Draw is not open to directors, members, partners, employees, agents or consultants of Deckers, any person who directly or indirectly controls or is controlled by Deckers, or any supplier of goods or services in connection with the Prize Draw, or their spouses, life partners, business partners or immediate family members.
- c) By entering the Prize Draw you hereby warrant that all information submitted by you is true, current and complete. Deckers reserves the right to verify the eligibility of all participants and disqualify a participant for submitting false information.

### 3. How does the Prize Draw work?

- a) No purchase is necessary to enter the Prize Draw and entry is free.

- c) Each participant can enter the Prize Draw once. Only the first Entry by each participant will be accepted and constitute a valid Entry.
- d) Each participant must be physically attending the Cancer Research UK London Winer Run to enter the lottery at the event itself.
- e) All Entries must be received by Deckers during the Prize Draw Period or they will be void. Deckers will not accept responsibility for:
  - i. Prize Draw Entries that are lost, mislaid, damaged, or delayed in transit, regardless of cause, including, for example, as a result of any postal failure, equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind; or
  - ii. any change in dates, times or cancellations or other arrangements that may prevent a winner from accepting, taking, or using a prize.
- f) During the duration of the competition, there is one winner who has the closest time to their prediction.
- g) The winners will be notified instantly after their participation at the event by HOKA staff member (“Email Notification”).
- h) In order to receive their Prize, the winners will also need to provide Deckers with any further information requested by Deckers, in accordance with the instructions set out in the

Notification within this Claim Period. Failure to claim the Prize in accordance with the instructions in the Notification within the Claim Period will result in the forfeit of the Prize and an alternative winner will be chosen.

i) The winners will receive the Prize on the same day and same place they participate to the lottery (as set out in clause 3(g)).

j) The winners may be required to provide Deckers with proof of identification in order to verify compliance with the eligibility requirements for the Prize Draw.

k) If the winner is found to be ineligible or fails to comply with the Terms, then the winner may, in Deckers' sole discretion, be disqualified and an alternate winner will be selected.

#### 4. What is the Prize?

a) There will be 1 individual winner.

b) Each winner will receive one pair of HOKAs

c) Prizes are non-transferable, non-exchangeable, and have a cash value of zero. Prizes are for personal use only and are not for resale. Prizes may be forfeited in the event that Deckers determines that the prize is being misused. Deckers reserves the right to substitute a prize of an equal or greater value in its absolute discretion.

#### 5. General

a) Deckers reserves the right to amend the rules of the Prize Draw, to withdraw the Prize Draw at any time if circumstances beyond its control make this unavoidable, or to cancel the Prize in the event of non-compliance with these Terms.

b) Deckers will use your personal details to contact you for administrative purposes relating to this Prize Draw.

c) If you have elected to be added to HOKA's email database, you will also receive promotional emails with offers, news, products and information. You can unsubscribe at any time.

d) Deckers will keep your personal information safe and will use your personal information in accordance with the privacy policy available on its website (<https://www.deckers.com/privacy-policy>).

e) Each winner's surname and county will be made available. Each winner will have the right to object to this information being published or to request a reduction in the amount of information being published. Deckers may be required to provide this information to the relevant regulatory authorities.

f) The decision of Deckers regarding any aspect of the Prize Draw is final and binding and no correspondence will be entered into about it.

g) Any cancellation or changes will be posted on the relevant Prize Draw landing pages, as set out in clause 3(b).
